We are writing on behalf of the World Association of Newspapers and the World Editors Forum, which represent 18,000 publications in 102 countries, to express our serious concern at proposals to enact a new Media Liability Act which may open the appointment of the Press Council to politicisation.

Greenland is currently subject to the Danish Media Liability Act, which determines who is legally responsible for media content and establishes the Greenland Press Council. The Press Council has powers to criticise mass media for content or conduct contrary to sound press ethics and may ask them to publish a reply to correct factual information which may cause significant financial or other damage.

Greenland's government has decided to adopt a new Media Liability Act. The act is heavily inspired by the Danish act but also contains several significant changes. The most important being that the Press Council will be composed of a president, two journalists, two editors and two representatives of the public. Until now, there has been both a president and a vice-president, both of whom are lawyers or judges; in practice the president has been a judge from Greenland's High Court.


We are concerned that under the current proposal, the Council's appointment and thus the decision-making process might become political. We respectfully remind you that it is of utmost importance that the Press Council continues to be – and seen to be – an independent institution. Consequently, we urge you to maintain the current modus operandi and legal expertise that have secured independence and public trust

As there are too few press complaints to establish a separate secretariat, we also suggest that an existing independent institution fulfils this role for the Press Council. Greenland's court administration seems to be ideal for this purpose, particularly as Greenland Home Rule will assume responsibility for the judicial system within a few years.


We respectfully call on you to do everything possible to ensure that appointment to the Press Council and its decision-making process remain apolitical and that the current structure that retains public confidence is maintained.
